Chairman Bill Mahomes convened a special telephonic meeting of the Board of Regents of The Texas A&M University System at 11:03 a.m., Thursday, June 6, 2024, in Room 2507, Memorial Student Center, on the campus of Texas A&M University, College Station, Texas.

Chairman Mahomes introduced Mr. Cage Sawyers, the 2024-25 student regent and welcomed him to his first board meeting. He said Cage is a third-year, Texas A&M Law School student.

**MINUTE ORDER 149-2024 (ITEM 1)**

**AUTHORIZATION TO GRANT A CONDITIONAL ROADWAY EASEMENT  
IN SAN ANTONIO, BEXAR COUNTY, TEXAS, TO THE CITY OF SAN ANTONIO,  
TEXAS A&M UNIVERSITY-SAN ANTONIO**

The Chancellor of The Texas A&M University System, or designee, following a review for legal sufficiency by the Office of General Counsel, is authorized to take all steps necessary to negotiate, execute and deliver a conditional roadway easement to the City of San Antonio, Texas for approximately 7.833 acres, to remain in effect so long as the property is used for roadway purposes, and to take any and all additional action, and execute any and all ancillary documents, deemed necessary to consummate the transaction.
