Vice Chairman Bob Albritton convened a special workshop meeting of the Board of Regents of The Texas A&M University System at 2:41 p.m., Thursday, August 1, 2024, in the Memorial Student Center, Bethancourt Ballroom E, College Station, Texas.

Vice Chairman Albritton announced that a quorum was present and that the Board would receive briefings from System executives and invited guests.

Trev Alberts, Athletic Director, Texas A&M University, provided a presentation on extracurricular activities at Texas A&M. He spoke about culture, business operations, student athlete experience, challenges and opportunities.

Jenny Jones provided a presentation on the upcoming 2025 session of the Texas Legislature. Her discussion included committees, budget, initiatives, affordability, Higher Education Fund (HEF) and research funding.

This included commercialization metrics, inventor engagement, USA patents, success stories, Plug & Play, and the Innovation Forward Conference scheduled for November 12-14, 2024, at Kyle Field. Regent Torn provided an update of the consulting study related to the A&M System's structure and operations.
